### FBI finds classified file in Pence's home

The Federal Bureau of Investigation (FBI) has found an additional classified file during a search of former US Vice President Mike Pence's home in In-

The search was conducted by FBI agents from Indianapolis and is not currently linked to other investigations into classified files, the BBC reported.

In a statement on Friday, Devin O'Malley, an adviser to Pence, said that the former Vice President agreed to the consensual search and the additional file was removed following "a thorough and unrestricted search".

"The Department of Justice

completed a thorough and unrestricted search of five hours and removed one document with classified markings and six ad-

ditional pages without such markings that were not discovered in the initial review by the vice-president's counsel," O'Malley added.
