

## Be prepared for any challenge that may come your way: Rajnath Singh

NEW DELHI

Defence Minister Rajnath Singh on Saturday said efforts are being made to resolve the differences on the Line of Actual Control (LAC) in eastern Ladakh through dialogue with China and that the process of disengagement has been completed at some places. In an address to the armed forces on the eve of the 75th Independence Day, Singh said the dimensions of security are constantly changing in the evolving environment and called upon the three services to be prepared for any challenge that may come their way.

"I call upon you to be prepared for any challenge that may come your way. I assure you that the government is ready and will continue to always meet your and your loved ones' needs," he said, in comments that came in the backdrop of the deteriorating security scenario in Afghanistan.

Singh said the Indian civilisation has always been peaceful since ancient times, but peace is not possible without power.

"If non-violence is our ultimate duty, protecting the integrity of the nation is equally important. There-



fore, we are ready to do anything for unity and nation," he said.

"In order to maintain prosperity in the country, you should be aware in protecting the situation along the border, you are in water, land and air."

## Sena leaders obstructing highway projects in Maha, says Gadkari

Union Minister of Road Transport and Highways Nitin Gadkari has written a letter to Maharashtra Chief Minister Uddhav Thackeray claiming that local leaders of the ruling Shiv Sena were creating obstructions for several road projects undertaken by his ministry in the state.

If the 'harassment' of contractors and officials by local leaders continued, the Union ministry will have to consider if these projects should continue, he warned in the missive, dated July 25.

The letter went viral on social media on Saturday. A source close to the Union minister confirmed its authenticity.

Incidentally, Gadkari was PWD minister in the Shiv Sena-BJP government in Maharashtra in the 1990s.

Several projects of four-laning of national highways and bridges are underway in Akola, Nanded, Washim and Osmanabad districts, but public repre-

sentatives from Thackeray-led Shiv Sena were obstructing these works, a senior BJP leader said.

Contractors and officials are being harassed with legal demands" and in some cases work has been stopped by local leaders, he alleged.
